

**NIDAAM DHAMEYSTIRAN EE GAADIKA DEEGAANKA PORTLAND  
(PACTS - PORTLAND AREA COMPREHENSIVE TRANSPORTATION SYSTEM)  
HABRACA CABASHOYINKA MIDABTAKOORKA XUQUUQAHADANIGA**

Qof kasto oo aminsaan in lola dhagmay sii midab takoor ah oo ku saleysan midab, asal wadan, aqoonta af Ingiriisiga oo xaddidan, jinsiga, da'da iyo lixaad laii, wuxuu xaq u leyahay in uu diiwangeliyo dacwo mudo ilaa iyo 180 maalmood gudohood laga bilabo marko eedaynta midab takooridu dhacday. Qofka dacwada samayenaaya wuxuu uu gudbin karaa dacwadisa waaxda Faderalka, gobolka, ama wakalada gabnaysa adeegga, sida Maamulka Wadooyinka Faderalka (FHWA - Federal Highway Administration), Maamulka Gaadiidka Dawladaa Dhaxe ee Faderaalka (FTA - Federal Transit Administration) ama Waaxda Gaadiidka ee Maine (MaineDOT – Maine Department of Transportation). Dacwadaas gof wakiil sharci ah ayaa diiwangalin karaa. Looma baahna aqoonsiga qofka dacwoonaya haddii macluumaad ku filan la helo go'aaminta aqoonsiga eedeysanaha oo muujineysa suurtagalnimada in xadgudub dhacay. Haddii dacwada lo gudbiyay PACTS, marka talaaboyinka soo socda ayaa la raaci doonaa:

- B. Dacwadaha waa inay ku jiraan macluumaadka soo socda:

- i. Magaca, cinwaan iyo lambarka taleefanka qofka ee dacwonaya haddii la heli karo.
- ii. Magaca iyo goobta ey ku sugaran tahay hay'adda fidineysa adeegga.
- iii. Nooca dhacdada oo keentay inuu dacwoodaha rumaysto midab takoorida in ay aheyd sabab.
- iv. Asaaska dacwada, tusaale, jinsi, midabka ama asalka wadanka, aqoonta af Ingiriisiga oo xaddidan, jinsigiiisa, da'da iyo lixaad li' ama itaal darri darted.
- v. Cinwannada, magacyada, iyo lambarada talefannada ee dadka laga yaabo inay aqoon u leyihiiin dhacdada.
- vi. Taariiqda ama taariikhaha ey dhacaday ama ey dhaceen eedeymaha mibatakoorku.
- vii. Diiwanka dacwada waxay hayndoona PACTS si loo diiwaangilyo iyo taariiqda PACTS ay u gudbisay dacwoda masuuliyiinta ku habboon ee federalka.

C. Habka baaritaanka dacwada

- i. Dacwooyinka ay heshay ama lasoo gadsiyay PACTS waa in lo gudbiya Waaxda Xuquuqda Madaniga MaineDOT sii lo qiimayo mudo 72 sacadood gudohood.
- ii. PACTS way gorii cabashada, dabadeedna waxay uu so diri qofkii cabashada soo dirtay warqaad cadaynaysa inay heshay cabashada.
- iii. MaineDOT way u gudbini cabashada hayada Federaalka ee ku habboon, haa ahato Maamulka Gaadiika Daweynaha ee heer Federal (dacwadaha laxidhidha baska, gaadidka lahayajiyay ama adeega su'al iyo jawaab-celinta), ama Maamulka waddoyinka wawen Gaadiidka Dawladaa Dhaxe ee Faderaalka (dacwadaha ku saabsan waddooyinka, buundooyinka, meelaha dadku ku socdaan, melaha logu talagalay dadka lugaynaya ama baaskilka) habraac iyo baarintaan suurtagal nogon kara dartii.
- iv. Haddii xafiska FHWA ee Xuquuqda Madaniga ah go'aamiyo Title VI ama cabasho ADA ee ku aadan PACTS inay MaineDOT kusamenkarto baarintaan, xafiska FHWA ee Xuquuqda Madaniga ah wuu u wakiilan kara hawsha baaritaanka dacwadaa Xafiska Xuquuqda Madaniga ee MaineDOT. MaineDOT waxay sameyn doonan baaritaanka wayna u gudbini doonaan warbixinta baarintaaka xafiska Xuquuqda Madaniga ee FHWA dib u eegis iyo go'an kama dambays ah darteed.
- v. Talabada dhamaan cabashoyinka ee cinwaanka VI waxaa fulin doona xafiska FHWA ee Xuquuqda Madaniga iyado oo loo maraya xallin aan rasmi ahayn ama soo saaritaan warqad ah helitaanka u hoggaansanaanta ama didmada hoggaansanaantaa cinwaanka VI iyo ADA. Copy ka mid ah wargada ee natijada waxa lo diri xafiska geybta FHWA.
